- 25 succeeding elections or more quickly if the reduction can be made by not
- 26 filling vacancies on the board and if desired by the board. If necessary

made in whole or in part through unfilled vacancies, the board may 1

In districts which have one director elected 6 from each subdistrict, each director elected from an even-numbered 7 subdistrict shall be elected for a two-year term and each director from 8 an odd-numbered district and any member to be elected at large shall be 9 elected for a four-year term. In districts which have two directors elected from each subdistrict, the four candidates receiving the highest 10 11 number of votes at the primary election shall be carried over to the 12 general election, and at such general election the candidate receiving the highest number of votes shall be elected for a four-year term and the 13 14 candidate receiving the second highest number of votes shall be elected 15 for a two-year term. Thereafter each director shall be elected for a four-year term. 16

- (2) The board of directors may choose to: (a) Nominate candidates 4 5 from subdistricts and from the district at large who shall be elected by 6 the registered voters of the entire district; (b) nominate and elect each 7 candidate from the district at large; or (c) nominate and elect 8 candidates from subdistricts of substantially equal population except 9 that any at-large candidate would be nominated and elected by the registered voters of the entire district.
