AN ACT to amend section 83-107.01, Revised Statutes Supplement, 1969, relating to public institutions; to change the names of the Boys' Training School and the Girls' Training School as prescribed; to harmonize with other legislation; to provide duties for the Revisor of Statutes; and to repeal the original section and also section 83-107.02, Revised Statutes Supplement, 1969.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 83-107.01, Revised Statutes Supplement, 1969, be amended to read as follows:

83-107.01. The official names of the state institutions under the supervision of the Department of Public Institutions shall be as follows: (1) Beatrice State Home, (2) Nebraska Orthopedic Hospital, (3) Lincoln Regional Center, (4) Norfolk Regional Center, (5) Hastings Regional Center, (6) Nebraska Veterans' Home, (7) Nebraska Penal and Correctional Complex, (8) ~~Boys' Training-School~~ Youth Development Center-Kearney, (9) ~~Girls'-Training-School~~ Youth Development Center-Geneva, (10) Nebraska Psychiatric Institute, (11) Nebraska Hospital-for-the-Tuberculous, ~~{12}~~ State Reformatory for Women, and ~~{13}~~ {12} Youth Diagnostic and Rehabilitation Center.

Sec. 2. Whenever the term Boys' Training School appears in the statutes, it shall, after the effective date of this act, be construed to mean and apply to the Youth Development Center-Kearney, and the Revisor of Statutes shall make the appropriate changes in the statutes. The sections in which such term appears are sections 83-466 to 83-471, Reissue Revised Statutes of Nebraska, 1943; and sections 60-1001, 71-901, 83-107.02, 83-108, 83-171, 83-465, 83-472, 83-473, and 83-1, 138, Revised Statutes Supplement, 1969.

Sec. 3. Whenever the term Girls' Training School appears in the statutes, it shall, after the effective date of this act, be construed to mean and apply to the Youth Development Center-Geneva, and the Revisor of Statutes shall make the appropriate changes in the statutes. The sections in which such term appears are sections 60-1001, 71-901, 83-107.02, 83-108, 83-171, 83-487, 83-490, and 83-1,138, Revised Statutes Supplement, 1969.

Sec. 4. That original section 83-107.01, Revised Statutes Supplement, 1969, and also section 83-107.02 Revised Statutes Supplement, 1969, are repealed.
