LEGISLATIVE BILL 547

Approved by the Governor May 8, 1979

AN ACT to amend section 33-105, Revised Statutes Supplement, 1978, relating to the Department of Water Resources; to change certain fees as prescribed; and to repeal the original section.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 33-105, Revised Statutes Supplement, 1978, be amended to read as follows:

33-105. There shall be paid to the Department of Water Resources in advance for the services of the Director of Water Resources by the party demanding or necessitating the service the following fees: filing, recording, and examining each application for a storage reservoir for the first each five thousand acre-feet or fraction thereof, ten twenty-five dollars, and for each additional five thousand acre-feet or fraction thereof, five ten dollars; for filing, recording, and examining each application for water for irrigation from a natural stream, or-from--a-storage reservoir, for the first one thousand acres proposed for irrigation or fraction thereof, tem two hundred dollars, additional thousand acres or fraction and for each thereof, five one hundred dollars; for filing, recording, and examining each application for water for irrigation from a storage reservoir, for the first one thousand acres proposed for irrigation or fraction thereof, fifty dollars, and for each additional thousand acres or fraction thereof, twenty-five dollars; for filing, recording, and examining each application for water for power purposes, for each theoretical fifty horsepower or fraction thereof, five dollars; for filing, recording, and examining each application for water for each stock water reservoir, fish pond, ice pond, or other useful purpose for which no fee has been fixed, ten dollars; for filing any petition, affidavit, or other paper, one dollar ter dollars; for recording any deed or document pertaining to land covered in whole or in part by a water appropriation or any instrument other than an application, ten dollars; one-dollars-for-tping-a transcript-or-copy-of-any-instrument-recorded-or-filed-in the office of the Department of Water Resources, - fifteen cents-for each one hundred words; for blueprint copy of any map or drawing or for other copy of drawings or

photostatic copy of any record, a reasonable sum to be fixed by the department in an amount estimated to cover the actual cost of preparing such a reproduction; for the examination of plans for any new dam and reservoir or enlargement, one dollar for each foot in height of the dam, and actual expenses while visiting and examining the site; dam; fifty-cents-for-each-foot-in-height--of--dam; and-the-actual-expenses-while-visiting-and-examining-the site-thereof; for certificate and seal, one dollar, except that for any document filed with the Director of Water Resources in his capacity as Secretary to the Nebraska Power Review Board there shall be no charge. The Director of Water Resources shall keep a record of all money thus received. At the end of each calendar month he shall pay the same to the State Treasurer for the use of the General Fund and take his receipt therefor and file the same with the records of his or her office.

Sec. 2. That original section 33-105, Revised Statutes Supplement, 1978, is repealed.
