Section 1.

AN ACT relating to anatomical gifts; to amend section 60-412, Revised Statutes Supplement, 1983; to provide for additional information on certain motor vehicle operators' licenses; to eliminate a decal provision; and to repeal the original section, and also section 60-406.02, Reissue Revised Statutes of Nebraska, 1943.

Statutes Supplement, 1983, be amended to read as follows:

That section

60-412,

Be it enacted by the people of the State of Nebraska,

The

60-412. director shall assign distinguishing number to each license issued and shall keep a record of the same which shall be open to public inspection. Any person requesting such driver record information shall furnish to the department the name of the person whose record is being requested and, when the name alone is insufficient to identify the correct record, the additional department may request identifying The department shall, upon request of any information. applicant, furnish a certified abstract of the operating record of any person and shall be entitled to charge such applicant a fee of one dollar per abstract. One hundred per cent of the fee on abstracts shall be deposited in the Department of Motor Vehicles Computerization Fund, which

is hereby created. Such fund shall be used to develop and operate a system of utilizing a computer to store and print any records and information as deemed necessary by the

director. Any money in the fund available for investment shall be invested by the state investment officer pursuant to sections 72-1237 to 72-1269.

The director shall also keep a record of all applications for licenses that are disapproved with a prief statement of the reason for disapproval of the application. The motor vehicle operator's license shall be in the form of a card of a size that may be conveniently carried on the person. Fach license shall be reason for disapproved believes that may be conveniently carried on the person. carried on the person. Each license card shall carry the following statements: Name; age; place of residence; post office address; a brief personal description of the

licensee sufficient for identification; the anatomical gift information specified in section 2 of this act; and such other facts and information, not inconsistent with

this act, as the director may determine.

Sec. 2. (1) Each motor vehicle operator's license shall provide anatomical gift information of the licensee on the back side of such license. The information shall include the following items to be completed by the licensee in the event that the licensee desires to make an anatomical gift:

(a) A suitable notation indicating that the

licensee is a donor;

(b) A designation as to which body organs or parts are being donated;

(c) A dated signature of the licensee; (d) The signatures of two witnesses (d) The signatures of two without witnessed the licensee's signature; and
(e) Such other information as the Director of

- (2) The anatomical gift information signature shall constitute sufficient legal authority for the removal of a body organ or part upon the licensee's death.
- (3) No such authorization of an anatomical gift may be noted upon the license of any person under the age of nineteen years.

 (4) The gift shall be renewed upon renewal of

each license.

Sec. 3. That original section 60-412, Revised Statutes Supplement, 1983, and also section 60-406.02, Reissue Revised Statutes of Nebraska, 1943, are repealed.
