

## LEGISLATIVE BILL 3

Approved by the Governor February 10, 1999

Introduced by Executive Board: Coordsen, 32, Chairperson

AN ACT relating to labor; to amend sections 48-1305, 60-328, and 60-488, Reissue Revised Statutes of Nebraska; to delete references to the Division of Employment of the Department of Labor which was eliminated in 1984; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

Section 1. Section 48-1305, Reissue Revised Statutes of Nebraska, is amended to read:

48-1305. (1) The commissioner shall cooperate with federal, state, and local agencies to coordinate the service programs established pursuant to section 48-1304. The commissioner, with the advice of the staff at the centers, shall promulgate rules concerning the eligibility of persons for the job training and other programs of the multipurpose service centers, the level of stipends for the job training programs, and a sliding fee scale for the service programs.

(2) The director of each center shall report to the commissioner, as prescribed by rule, and shall evaluate the effectiveness of the job training, placement, and service to displaced homemakers, including the number of persons trained, the number of persons placed in employment, followup data on such persons, the number of persons served by the various service programs, and cost-effectiveness of the various components of the center.

(3) Staff of the service center shall assist the displaced homemaker in finding permanent employment. To this end, the commissioner and the service center staff shall work with ~~the Division of Employment of the Department of Labor and any other agency~~ other agencies to secure employment for displaced homemakers.

(4) The director of each center may accept, use, and dispose of contributions, whether public or private, of money, services, and property to carry out the purposes of ~~sections 48-1301 to 48-1309~~ the Nebraska Equal Opportunity for Displaced Homemakers Act.

Sec. 2. Section 60-328, Reissue Revised Statutes of Nebraska, is amended to read:

60-328. The provisions of sections 60-301 to 60-326.01 relative to registration and display of registration numbers shall not apply to a motor vehicle owned by a nonresident of this state, other than a foreign corporation doing business in this state, if the owner thereof has complied with the provisions of the law of the foreign country, state, territory, or federal district of his or her residence relative to registration of motor vehicles and the display of registration numbers thereon and conspicuously displays his or her registration numbers as required thereby.

The provisions of this section shall be operative as to motor vehicles owned by a nonresident of this state only to the extent that, under the laws of the foreign country, state, territory, or federal district of his or her residence, like exemptions and privileges are guaranteed to motor vehicles duly registered under the laws of and owned by residents of this state or to a vehicle duly licensed in the state of residence and operated by a nonresident agricultural worker, certified by the Department of Labor, ~~Division of Employment~~, as engaged in temporary agricultural employment in this state, for a period of not to exceed sixty days. If a truck, truck-tractor, semitrailer, or trailer is lawfully licensed under the laws of another state or province and is engaged in hauling grain or other seasonally harvested products from the field where they are harvested to storage or market during the period from June 1 to December 15 of each year or under emergency conditions, the right to operate over the highways of this state for a period of ninety days shall be authorized by obtaining a permit therefor from the county treasurer or his or her agent. Such permit shall be issued upon the payment of a fee of twenty dollars for a truck or one hundred fifty dollars for any combination of truck, truck-tractor, semitrailer, or trailer. The fees for such permits, when collected, shall be remitted to the Department of Motor Vehicles which shall remit them to the State Treasurer for credit to the Highway Cash Fund.

Sec. 3. Section 60-488, Reissue Revised Statutes of Nebraska, is amended to read:

60-488. (1) A nonresident shall not be prevented from operating a motor vehicle upon the highways of this state during the period within which

he or she may lawfully operate such motor vehicle in the state under the general motor vehicle laws of this state, but in no event shall such immunity extend beyond a period of thirty days continuous residence in the State of Nebraska.

(2) Subsection (1) of this section shall be subject to the following limitations:

(a) Such nonresident shall be duly licensed under the motor vehicle laws of the state of his or her residence or have complied with the laws of the state of his or her residence relating to the registration or licensing of motor vehicles and conformed to the laws of such state of residence in relation to the operators of motor vehicles;

(b) A nonresident who is serving in this state on active duty as a member of the United States Armed Forces, or the spouse of any such person or a dependent of such member of the armed forces, shall be exempt from the licensing requirements of this state if he or she is duly licensed under the laws of the state of his or her residence;

(c) A nonresident who is considered to be a full-time student in any institution of postsecondary education in this state shall be exempt from the licensing requirements of this state if such person is duly licensed under the laws of the state of his or her residence; and

(d) A nonresident certified by the Department of Labor, ~~Division of Employment~~, as engaged in temporary agricultural employment in Nebraska for a period of not to exceed sixty days may be granted an additional thirty days' immunity if a similar immunity is granted by the state of his or her permanent residence to residents of Nebraska while temporarily employed in agricultural employment in such state.

Sec. 4. Original sections 48-1305, 60-328, and 60-488, Reissue Revised Statutes of Nebraska, are repealed.
