LB 1138 allows a prescriber who issues less than fifty (50) prescriptions a year to be exempt from controlled substance prescription requirements as described in Nebraska § 38-1,146.

LB 1138 would have a minimal fiscal impact on the Department of Health and Human Services (DHHS). DHHS would need to update website references to the statute and communicate the change to staff and Board of Pharmacy members.
