Section 4 allows the NSHS to enter into an agreement with the Willa Cather Foundation to transfer clear title of any properties described in section 82-130 from the State of Nebraska to the Foundation at no cost to either the society or foundation other than any property transfer transactional costs to be shared equally. Statement of Intent:

During the last fiscal year, federal receipts were approximately 30 percent of the state's total appropriations. Currently, federal grant applications are initiated and managed by each agency individually. While federal funds are appropriated in budget bills, they are typically shown as estimates, and the commitments incurred or other maintenance of effort requirements are typically only known to the agencies dealing directly with the funds. LB611 bill would require the annual reporting of federal funds received by agencies participating in the state budgeting process. The report will also require each agency to report operating plans in the event federal receipts are reduced by 10% or more and 25% or more. This is necessary so that the executive and legislative branches are prepared to act in the best interests of Nebraska's stakeholders should funding be reduced.

LB775 authorizes the Nebraska Game and Parks Commission to utilize alternative methods of contracting for public projects for buildings in the state park system, specifically authorizing the use of the Design-Build and Construction Manager/General Contractor contracting methods. Through previous legislation, public schools, cities, villages, community colleges and state colleges have been provided the ability to use alternative delivery methods in addition to the traditional Design-Bid-Build method. LB775 would provide the Commission the option and ability to use these alternative methods of contracting, which they currently do not have. AM1946 states that an incident involving one or more crimes will be identified as a single incident. The amendment puts in place a process for filing and paying of a claim as provided by the State Miscellaneous Claims Act. AM1946 also applies to any correctional institution incident retroactive to on or after May 1, 2015. LB861 had an amendment (AM2854) that was adopted after AM1946. This bill, as amended, has the potential for a fiscal impact to the state, but that amount, if any, is not able to be determined at this time.

Statement of Intent:

The purpose of LB938 is to modify the current deposit rule to better guide when and how much the state should save. Currently, deposits to the Cash Reserve Fund are based on surpluses resulting from when revenue exceeds the forecast. This is commonly referred to as depositing based on forecasting error. If revenues are growing faster than normal, then a percentage of that excess revenue could be transferred to the Cash Reserve Fund. This ensures the largest deposits are made when revenue growth is highest, while also preventing extraordinary tax collections from funding recurring expenditures. LB938 would cap the deposits allowed into the Cash Reserve Fund so that it does not exceed 16% of expenditures to allow for other budgetary priorities. LB938 would add a supplementary deposit rule to the current forecasting error method. The greater of the two would be the amount which is deposited into the Cash Reserve Fund. The formula for the alternative rule is as follows: $50\% \times (\text{Actual revenue, current FY} \times [\text{Annual \% increase, current FY} - \text{Average annual \% increase, 10-year}])$.

Under LB938, the amount to transfer shall be the greater of (a) actual General Fund net receipts for the most recently completed fiscal year minus estimated General Fund net receipts for such fiscal year; or (b) fifty percent of the product of actual General Fund net receipts for the most recently completed fiscal year times the difference between the annual percentage increase in the actual General Fund net receipts for the most recently completed fiscal year and the average annual percentage increase in the actual General Fund net receipts over the ten previous fiscal years. Under LB938, transfers to the Cash Reserve Fund could be required even if actual receipts were substantially below forecast.

LB 1055 removes the Intern Nebraska program from the Job Training Cash Fund and creates the Intern Nebraska Cash Fund. All funds in the Job Training Cash Fund that were dedicated to carrying out the Intern Nebraska program but were not yet expended are to be transferred to the Intern Nebraska Cash Fund.
